4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

LARGE SPILLS

Prevent further leakage or spillage if safe to do so. Slippery when spilt. Avoid accidents, clean up immediately.
