2. Eligibility

- **Residency:** Open to residents of Arizona. Entrant must be a homeowner prior to May 30, 2025.

5. Prize

(2) **Installation Site Eligibility:** Installation site must be reasonably accessible and must meet local code and safety requirements.

- Major electrical, roofing, or ductwork modifications.
- Asbestos removal or remediation.
- City or HOA fees not typically covered in standard installations.
- Upgrades, accessories, or premium system add-ons.
